Candidate Information

To obtain nomination papers, candidates must come in to the City Clerk's Office during the nomination period to meet with the City Clerk in order to obtain a Candidate's Handbook, which contains nomination papers and other important forms and information. "Pulling" nomination papers will take approximately 30-45 minutes. This must take place during normal business hours: Monday through Thursday from 8:00 a.m. to 5:30 p.m.

There is no cost to be issued nomination papers, receive a Candidate's Handbook, which is provided free to all persons considering becoming a candidate, nor is there a fee to file nomination papers; however, there is a fee to file a candidate statement if the candidate so desires.
